### **Lodging Nominations**

Nominations **must be** handed to the Returning Officer during the directed time within the meeting which commences at 1:30pm (Australian Eastern Standard Time (AEST)) on Thursday 3 July 2025 at the meeting venue 17 Federal Street, NORTH HOBART, TAS 7009.

Each nominee shall be a member of the TAS Branch Council and shall be proposed and seconded by two (2) members of the TAS Branch Council.

A nomination shall only be valid after the candidate has signified his acceptance of the nomination.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

### **Voting Period**

An attendance ballot, **if required**, will be conducted at the meeting 17 Federal Street, NORTH HOBART, TAS 7009. The Returning Officer will confirm the exact timing of such voting period at the meeting, if required.

### **Absent Voting**

A member of the TAS Branch Council who is entitled to vote, and who will be absent during the period of the election may apply for an absent vote.

Should an absent application be received, the counting of the votes will be set aside until time has been allowed for return of the absent vote.

**PLEASE NOTE:** Completed Absent Vote Applications must reach the Returning Officer **not later than** prior to printing of ballot papers at the branch council meeting on Thursday 3 July 2025.
