Lodging Nominations

Nominations open Tuesday 17 June 2025 and must reach the Returning Officer, Jackie McHenry **not later than** 8am (Australian Western Standard Time (AWST)) on Tuesday 24 June 2025.

Nominations must be lodged by email.
