Election of Branch Secretary

Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from Tuesday 10 June. The nomination form must then be lodged in accordance with the Organisation's rules.

Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 8am (Australian Eastern Standard Time (AEST)) **on Tuesday 17 June 2025**.

How to lodge nominations: Nominations must be lodged by email.

A properly completed nomination form including all necessary signatures and attachments should be scanned and submitted as a **PDF** file to IEBnominations@aec.gov.au

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.

Candidate Statements

Candidates may choose to submit a statement to be included with ballot material. The material **may include**:

- A statement of **up to** 200 words per candidate, provided in **Microsoft Word format**
- and include a passport sized photograph, provided in **JPG format**

Only statements which comply with the Rules and are received by the Returning Officer by 12 noon AEST on Tuesday 24 June 2025 can be accepted.

Voting Period

The ballot, if required, will open on Tuesday 1 July 2025 and close at 10am AEST on Tuesday 29 July 2025.

Scrutineer Appointment

The appointment of scrutineers closes at 10am AEST on Tuesday 22 July 2025.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
