Lodging Nominations

Nominations **must be** handed to the Returning Officer during the directed time within the meeting which commences at 8am (Australian Western Standard Time (AWST)) on Tuesday 24 June 2025 at the meeting venue Unit 5/375 Charles St, NORTH PERTH WA 6006.

Each nominee shall be a member of the WA Branch Council and shall be proposed and seconded by two (2) members of the WA Branch Council.

Note: The National Executive Member is to be elected from amongst the National Councillors elected at the meeting.

A nomination shall only be valid after the candidate has signified his acceptance of the nomination.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Voting Period

An attendance ballot, **if required**, will be conducted at the meeting venue Unit 5/375 Charles St, NORTH PERTH WA 6006. The Returning Officer will confirm the exact timing of such voting period at the meeting, if required.

Absent Voting

A member of the WA Branch Council who is entitled to vote, and who will be absent during the period of the election may apply for an absent vote.

Should an absent application be received, the counting of the votes will be set aside until time has been allowed for the return of the absent vote.

PLEASE NOTE: Completed Absent Vote Applications must reach the Returning Officer **not later than** prior to printing of ballot papers at the branch council meeting on Tuesday 24 June 2025.
