Lodging Nominations

Nominations open Tuesday 24 June 2025 and must reach the Returning Officer, Jackie McHenry **not later than** 3pm (Australian Eastern Standard Time (AEST)) on Tuesday 1 July 2025.

Nominations must be lodged by email. Only statements which comply with the Rules and are received by the Returning Officer by 12 noon AEST on Tuesday 8 July 2025 can be accepted.
