Lodging Nominations

Nominations **must be** handed to the Returning Officer during the directed time within the meeting which commences at 3pm (Australian Eastern Standard Time (AEST)) on Thursday 19 June 2025 at the meeting venue Level 10, Jubilee Place; 470, St Pauls Terrace; FORTITUDE VALLEY QLD 4006

Each nominee shall be a member of the QLD Branch Council and shall be proposed and seconded by two (2) members of the QLD Branch Council.

A nomination shall only be valid after the candidate has signified their acceptance of the nomination.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Voting Period

An attendance ballot, **if required**, will be conducted at the meeting venue Level 10, Jubilee Place; 470, St Pauls Terrace; FORTITUDE VALLEY QLD 4006. The Returning Officer will confirm the exact timing of such voting period at the meeting, if required.

Absent Voting

A member of the QLD Branch Council who is entitled to vote, and who will be absent during the period of the election may apply for an absent vote.

Should an absent application be received, the counting of the votes will be set aside until time has been allowed for the return of the absent vote.
